

TERMS & CONDITIONS

E.N.Z.A Soldiers is a collection of digital artworks (NFTs) running on the Ethereum Blockchain. Users are entirely responsible for the safety and management of their own private wallets and validating all transactions and contracts generated before approval. Furthermore, as the E.N.Z.A Soldier smart contract runs on the Ethereum Blockchain, there is no ability to undo, reverse, or restore any transactions. This website is only an interface providing information to participants and in no context should be considered financial advice. These NFTs will be traded and sold on the secondary marketplaces after the mint process. You Understand and agree that we will not be liable to you or any third party for damages which you may incur.

OWNERSHIP & OBLIGATIONS

I. You Own the NFT. Each E.N.Z.A Soldier is an NFT on the Ethereum Blockchain. When you purchase a NFT, you own the underlying Soldier, the Art, completely. Ownership of the NFT is mediated entirely by the Ethereum Blockchain: at no point may we seize, freeze, or otherwise modify the ownership of any E.N.Z.A Soldier without prior notification to the holder.

II. Personal Use. Subject to your continued compliance with these Terms, E.N.Z.A Soldiers grant you a worldwide, royalty-free license to use, copy, and display the purchased Art, along with any extensions that you choose to create or use, solely for the following purposes. 1. Personal Use. 2. The display of your artwork on any third-party platform as long as the platform cryptographically verifies the owner of the NFT.

III. Commercial Use. Subject to your continued compliance with these Terms, E.N.Z.A Soldiers grants you an unlimited, worldwide license to use, copy, and display the purchased Art for the purpose of creating derivative works based upon the Art. Examples of such Commercial Use would be the use of the Art to produce and sell merchandise products (T-Shirts etc.) displaying copies of the art on third party website or application as long as they cryptographically verify each NFT, so that the actual E.N.Z.A Soldier owner can display the Art, and provided that the Art is no longer visible once the owner of the Purchased E.N.Z.A Soldier leaves the website or application.

IV. Owning one of these NFTs does not give you any rights to any other trademarks or other intellectual property rights belonging to E.N.Z.A Soldiers or other related entities.
